There is coverage for law suits as well. Management liability, employment related practices, Cyber liability, extortion coverage, FFD is very well protected in the liability section. Accident and Sickness Policy – this compliments the W/C. Chief Bailey was concerned with the disability benefits. Ms. Ney reported on what the dept. has now according to the first 28 days. She will bring additional information. After some discussion to upgrade the benefits the Board requested Ms. Ney to send options on the details of increasing the amount for the benefits.
