Mr. Bene brought the only new Copy Machine with them to let the Board see how it works. They will install the machine and train all the officers how to use it. This Machine is half the size of the old one (12 years old) and is a do it all Machine. It copies, faxes, scans, separates and staples. \$8989.00 to buy outright, we can also lease the machine for \$159.00 a month. Maintenance is a separate deal of \$900.00 annually. Lease it for 5 years, after 5 years we can either return the machine or purchase it minus After some discussion and addition, it was decided to purchase the machine outright. Director Mulvihill motion to purchase the machine outright and get the Maintenance program together for a total of \$9685.65 – A roll call vote was taken as follows:
