 permission to obtain bids for repairing the roof. Recommended the fence project be put on hold
 for the time being and prioritize the roof repairs. Consensus of the Board was to have Chief M.
 Bailey call the insurance co. and obtain bids for the next meeting. President Ogilvie had this
 moved to 13A for more discussion and vote.

New Hires –

Received several applications. An interview is scheduled for Wednesday March 1 for one of the applicants to assist with shift duty.

Stockton East called and asked for a support letter from the Fire Department in receiving the flood
water from the Dam. Chief Bailey was concerned with them trying to take over the Farmington
Dam but was assured they were not. After some discussion The Board denied sending a letter and
chose not to get involved.
